_____ 2.) SELLER EXPRESSLY WARRANTS TO DISCLOSE ANY HEALTH CONDITIONS ***KNOWN TO SELLER*** AT TIME OF SALE. **ALL PURCHASERS ARE HEREBY PUT ON NOTICE THAT CHANGES IN DIET AND/OR SURROUNDINGS MAY INCREASE SUSCEPTIBILITY OF STRESS RELATED COMPLICATIONS OR HEALTH PROBLEMS.**

_____ 3.) SELLER EXPRESSLY WARRANTS AGAINST PARVOVIRUS, DISTEMPER, HEPATITIS, CORONA VIRUS FOR *TEN (10) DAYS* FROM DATE OF PURCHASE. SELLER FURTHER EXPRESSLY WARRANTS AGAINST HEREDITARY AND CONGENITAL DEFECTS FOR *ONE (1) YEAR* OF PURCHASE DATE. **SELLER HEREBY NOTIFIES BUYER THAT ANY AND ALL WARRANTIES PROVIDED HEREIN SPECIFICALLY *EXCLUDE* HYPOGLYCEMIA (LOW BLOOD SUGAR).** PURCHASER'S FAILURE TO PROVIDE WRITTEN NOTICE TO SELLER OF ANY CLAIM ARISING FROM ANY WARRANTY OUTLINED HEREIN, HEREBY CONSTITUTES A FULL AND COMPLETE WAIVER OF SAID WARRANTY AND RENDERS SAID WARRANTY NULL AND VOID. FURTHER, WHEN MAKING A CLAIM UNDER THIS WARRANTY, PURCHASER MUST PROVIDE SELLER WITH A STATEMENT FROM A LICENSED VETERINARIAN. SAID STATEMENT MUST INCLUDE A DIAGNOSIS AND PROGNOSIS. **SELLER RESERVES THE RIGHT TO HAVE ANY AND ALL PUPPIES EVALUATED BY A LICENSED VETERINARIAN OF SELLER'S CHOICE.**

PURCHASER'S FAILURE TO MAINTAIN CURRENT PUPPY VACCINATIONS OR MAINTAIN CURRENT AND CONTINUAL CARE OF A LICENSED VETERINARIAN FROM THE DATE OF PURCHASE HEREBY VOIDS ANY AND ALL WARRANTIES OUTLINED HEREIN, WHETHER EXPRESS OR IMPLIED. PURCHASER'S FAILURE TO SEEK A LICENSED VETERINARIAN WITHIN FOUR (4) BUSINESS DAYS FROM THE DATE OF PURCHASE HEREBY VOIDS AND WAIVES ANY AND ALL WARRANTIES GUARANTEED HEREIN, WHETHER EXPRESS OR IMPLIED.

_____ 6.) SELLER WARRANTS TO SELL ONLY PET QUALITY PUPPIES FOR COMPANION PURPOSES ONLY AND HEREBY MAKES NO GUARANTEE THAT ANY PUPPY SOLD BY SELLER IS SHOW QUALITY OR BREEDING QUALITY.

_____ 7.) SELLER HEREBY NOTIFIES BUYER THAT TESTICLES ARE NOT GUARANTEED TO DROP AND FEMALES ARE NOT GUARANTEED TO REPRODUCE.

_____ 8.) IF PURCHASER BELIEVES A PUPPY SUFFERS FROM ANY DISEASE OR DEFECT SPECIFICALLY OUTLINED HEREIN, PURCHASER **MUST** NOTIFY SELLER IN WRITING BEFORE THE VETERINARIAN ASSISTANCE IS OBTAINED. FAILURE TO NOTIFY SELLER AS OUTLINED HEREIN CONSTITUTES A WAIVER AND HEREBY VOIDS ANY AND ALL WARRANTIES PROVIDED HEREIN, WHETHER EXPRESS OR IMPLIED.

_____ 9.) UPON A VALID CLAIM UNDER THE WARRANTIES OUTLINED IN PARAGRAPH 3, ABOVE, SELLER HEREBY WARRANTS TO ISSUE A CREDIT FOR THE FULL PURCHASE PRICE TOWARDS A REPLACEMENT PUPPY. NO REFUNDS WILL BE GIVEN, UNDER ANY CIRCUMSTANCES.
